Speaker for September 9, 2010 Meeting

The speaker for the September 9th meeting will be Deborah M. Dennis, Ph.D. Dr Dennis is Executive Director of Human Systems Research, Inc.(HSR), a non-profit anthropological research organization at Las Cruces. Debra will speak and give a power point presentation on Ancestral Puebloan and Mogollon habitation and settlements in our area. Through HSR's Canana Alamosa Project, movement and identity of residents from the 7th through 12 centuries have been tied to ceramic, architectural and pithouse data in this area.

Dr. Dennis comes to us with a reputation as an excellent and informative speaker. Please invite spouses, family members and guests for this opportunity to hear an educational and interesting speaker discuss the pre-history of this region.

The speaker for the October 14th meeting will be Dan Carkozy, Special Agent with the Federal Bureau of Investigation in Las Cruces. Mr. Carkozy will discuss with us the FBI's weapons training, certification, instructions and local law enforcement problems and efforts. Dan has 15 years experience with the FBI, and by October he should be back from his September elk hunting trip and may even discuss that. Please try to attend the October meeting.

NEWTOWN, Conn --(Ammoland.com)- All Gun Owners, Hunters and Shooters:

With the fall hunting season fast approaching, the Environmental Protection Agency (EPA) under Lisa Jackson, who was responsible for banning bear hunting in New Jersey, is now considering a petition by the Center for Biological Diversity (CBD) – a

leading anti-hunting organization – to ban all traditional ammunition under the Toxic Substance Control Act of 1976, a law in which Congress expressly exempted ammunition.

If the EPA approves the petition, the result will be a total ban on all ammunition containing lead-core components, including hunting and target-shooting rounds. The EPA must decide to accept or reject this petition by November 1, 2010, the day before the midterm elections.

Today, the EPA has opened to public comment the CBD petition. The comment period ends on October 31, 2010.

The National Shooting Sports Foundation (NSSF) — *the trade association for the firearms, ammunition, hunting and shooting sports industry* – urges you to submit comment to the EPA opposing any ban on traditional ammunition. Remember, your right to choose the ammunition you hunt and shoot with is at stake.

The EPA has published the petition and relevant supplemental information as Docket ID: EPA-HQ-OPPT-2010-0681.
